The meeting was called to order by President Monte Rans at Don Hattan Chevrolet. We welcomed guests Frank Duvanel who has a white '93 and Vickie Dixon & Ron Cole. A correction was made to the minutes...the PO Box fee is annual not bi-annual. The minutes were approved as altered. Monte introduced Kip Smith from the Thunder hockey team. He invited us to their car show on March 22 from 3:30-7:00. The registration is \$20.00 in advance or \$25.00 the day of. Dues for renewals are payable on September 1st and are considered delinquent after the November A.C.C.C. meeting. Renewals received after the November meeting will be considered as new. Memberships received after September 1st will be valid through the next calendar year.
