## ACCC Constitutional Amendment

At the October meeting the club voted to drop out of the National Council of Corvette Clubs, obtain our own insurance from Hagerty and set the club dues at \$25.00 per year. Because of these changes, the club Constitution needs to be amended. This Amendment will be voted on at the November meeting. The amendment is as follows:

### Article II - Membership

#### Section 6 - Dues

The dues for each type of membership shall be as established by the membership.

\* If the ACCC is affiliated with any National and/or Regional Corvette organization, affiliate membership dues as established by the affiliate shall be considered mandatory with regular Club membership.

Dues are payable on September 1 and are delinquent after the annual meeting. Any memberships renewed after this date shall be considered new memberships.

### Article III - Government

#### Section 2 - Officers

- f. The **Events Chairman** shall be responsible for scheduling and maintenance of all Club activities and/or events. The Events Chairman shall be responsible for all matters pertaining to the National and/or Regional affiliated organization (If applicable). The Events Chairman shall be accountable to the President, Executive Board and the general membership.
